The India Justice Report is an initiative led by Tata Trusts in collaboration with organizations such as Centre for Social Justice, Common Cause, and Commonwealth Human Rights Initiative, among others. It aims to assess and rank the capacity of states in delivering justice across various parameters.

The report was first published in 2019, indicating its establishment and periodic nature. Since then, it has been providing comprehensive analysis and insights into the justice system of India.

In the 2022 edition of The India Justice Report,

- It is highlighted that only Kerala managed to achieve case clearance rates of 100 percent and more at both the High Court and subordinate court levels. This achievement reflects Kerala's efficiency in handling and resolving cases within the judicial system.
- Sikkim has topped among smaller states (states with a population up to 1 crore). It is followed by Arunachal Pradesh (2nd), and Tripura (3rd).
- Goa is at rank 7th which is the lowest.
- Only Arunachal Pradesh reports having CCTV (Closed-Circuit Television) cameras in all 14 spots (as directed by the Supreme Court) in all its 24 police stations.

Solution:

The Reserve Bank has undertaken a comprehensive review of the system of processing of applications for registration as Core Investment Companies (CICs) to make the registration process smoother and hassle free. Accordingly, the application form has been revamped to make it structured and aligned with the extant CIC regulations. Also, the number of documents to be furnished along with the application form has been reduced to 18 from the existing set of 52 documents to make the registration process user friendly.



A core investment company is a non-banking financial organisation that:

- (i) It has assets of at least Rs 100 crore.
- (ii) Engages in the business of acquiring shares and securities and meets the requirements listed below as of the date of the most recent audited balance sheet: -
- (iii) It holds at least 90% of its net assets in the form of equity shares, preference shares, bonds, debentures, debt, or loans in group companies.
- (iv) Its investments in equity shares (including instruments compulsorily convertible into equity shares within a period of not more than ten years from the date of issue) in group companies account for at least 60% of its net assets, as mentioned.
- (v) It does not engage in any other financial activity covered by Sections 45I(c) and 45I(f) of the RBI Act of 1934, with the exception of investing in bank deposits, money market instruments, government securities, loans to and investments in debt issuances of group companies, or issuing guarantees on behalf of group companies.
- (vi) It does not trade in its investments in shares, bonds, debentures, debt, or loans in group companies except through block sale for the purpose of dilution.
- (vii) It accepts public funding.

With this portal, Department of Animal Husbandry and Dairying (DAHD) will facilitate the regulatory approval process with transparency to assess and examine veterinary product proposals will be more streamlined through seamless integration with the SUGAM portal of Central Drugs Standard Control Organization.

This initiative would also provide valuable support to researchers and industries from a commercial perspective. By raising awareness among livestock rearies and improving logistical facilities, there would be an increase in the consumption of drugs.

DAHD has been working towards improving the regulatory process through setting up empowered committees such as Empowered Committee for Animal Health (ECAH), chaired by Principal Scientific Adviser (GoI), which is working towards creating resilient, farmercentric animal health systems in India and bringing forth changes to ensure the long-term success of India's livestock sector. Under ECAH, Regulatory Subcommittee, consisting of various veterinary experts from industry and academia, has been set up with the goal to comprehensively deliberate, efficiently take action, and provide recommendation/policy inputs on submissions of veterinary vaccine/biologicals/drugs in the Department for its opinion.

The setting up of the C-PACE is part of the several measures taken by MCA in the recent past towards Ease of Doing Business and ease of exit for the Companies. The C-PACE office will work under the supervision/administration of Director General of Corporate Affairs. (DGCoA), New Delhi. To establish the C-PACE, the Ministry amended the Companies (Removal of Names of Companies from the Register of Companies) Rules, 2023 which has come in effect from 1st May, 2023.

The Office of C-PACE was inaugurated on 1<sup>st</sup>May 2023 by Shri R.K. Dalmia, Director, Inspection & Investigation, MCA. Shri Harihara Sahoo, ICLS, has been appointed as first Registrar of the office of C-PACE. The C-PACE office will work under the supervision/administration of Director General of Corporate Affairs. (DGCoA), New Delhi.

Finance Minister Nirmala Sitharaman proposed the establishment of a Centre for Processing Accelerated Corporate Exit (C-PACE) in the Union Budget 2022-23. This will implement an expedited corporate exit process in 2022-23 fiscal.

C-PACE has been established as part of several measures taken to further improve the ease of doing business and ease of exit for companies. The C-PACE institution, established under sub-section (1) of section 396, shall be in operation through the Registrar of Companies (RoC) for the purposes of exercising functional jurisdiction of processing and disposal of applications. C-PACE will help to reduce the stress on the Registry along with keeping the registry clean besides availability of more meaningful data to the stakeholders. The C-PACE will also benefit the stakeholders by providing hassle-free filing, timely and process-bound striking off their company's names from the register.

The 2nd edition of "National Manufacturing Innovation Survey (NMIS) 2021-22: Summary for Policymakers", a joint study by the Department of Science & Technology (DST) and the United Nations Industrial Development Organization (UNIDO), to evaluate the innovation performance of manufacturing firms in the India has been released by Dr. Srivari Chandrasekhar, Secretary, DST, Ministry of Science & Technology (MoST).

The survey states that Karnataka is the most "innovative" state with index score of 33.41, followed by Dadra and Nagar Haveli, Daman and Diu (DNH&DD), Telangana, and Tamil Nadu.

Apart from North-eastern states except Assam (19.69), low-performing states include Bihar (21.32), Jharkhand (22.78), and Odisha (23.05).

Telangana, Karnataka, and Tamil Nadu have the highest share of innovative firms at 46.18%, 39.10% and 31.90%, respectively, with Odisha, Bihar, and Jharkhand reporting the lowest share of such firms at 12.78%, 13.47% and 13.71%, respectively. Uttarakhand (31.72) has the highest score among the hill states, while DNH&DD has the highest score among the UTs.

- The report states that India has doubled its share of global commercial services exports to 4.4 percent in 2022 from 2 percent in 2005.
- The report has stated that China has also doubled its share of global commercial services exports from 2005 to 2022, from 3% to 5.4%.

- Services value-added accounted for 51% of India's total exports in 2018, reflecting reforms to attract foreign direct investment (FDI).

- These categories are further divided into 6 domains,, Learning Outcomes (LO), Access (A), Infrastructure & Facilities (IF), Equity (E), Governance Process (GP) & Teachers Education and Training (TE&T).
- PGI 2.0 for 2021-22 classified the States/UTs into ten grades viz., highest achievable Grade is Daksh, which is for State/UT scoring more than 940 points out of total of 1000 points.
- The lowest grade is **Akanshi-3** which is for score up to 460.

Note: PGI was first released for the year 2017-18.

#### Key highlights of PGI 2.0:

- **Kerala** attained a score of **609.7**, Gujarat (599.0 score), Puducherry (592.7 score), Tamil Nadu (590.4 score), and Maharashtra (583.2 score) under Grade: PRACHESTA-3.
- Haryana attained a score of 577.9, and Rajasthan attained a score of 577.5 under Grade: AKANSHI-1.

**Ambubachi Mela**, an annual Hindu festival, is observed at the **Kamakhya Temple** in **Guwahati**, **Assam**. The festival marks the annual menstruation of the presiding Goddess in the Kamakhya Temple. The fair is an occasion to promote menstrual hygiene among visitors through the use of sanitary pads.

In 2023, the fair has been organized for four days (23 to 26 June).

#### Kamakhya Temple:

- Kamakhya is one of 51 Shakti peethas or holy sites for the followers of the Shakti cult, each representing a body part of the Sati, Lord Shiva's companion.
- The temple's sanctum sanctorum houses the yoni (female genital) symbolised by a rook.
- The temple is situated on the Nilachal Hills, whose northern face slopes down to the Brahmaputra River.
- According to the legends, it was built by the demon king Narakasura but records are available only from 1565 when Koch king Naranarayana rebuilt the temple.

Note: The attainment of womanhood of girls in Assam is celebrated with a ritual called Tuloni Biya, meaning small wedding.
